



## BOARD UPDATE

The GRHA Board resumed their regularly scheduled meetings on September 15, 2008, after a summer break.

Since the main topic was the condition of our roads, the Board set a meeting with Don Kile for September 16, 2008. As a result, the GRHA Board wrote a letter to Don Kile and Art Reichsfeld dated September 19, 2008 requesting the main roads of Burntwater, Vista Del Oro, and Goldfield Rd. be graded every 3-4 weeks and the secondary roads be graded every two months until the roads are paved.

On September 17, 2008, the Board of Supervisors approved the re-zoning for the Preserve. There are many other issues regarding the Preserve that will need to be approved before any building or construction begins.

Don Kile will hold a meeting with the Goldfield Ranch residents at 4:00 p.m. in the Fountain Hills Community Center on September 23, 2008 to further discuss the road issues.

The GRHA annual dues of \$75.00 are to be paid to Janet Heekin, Treasurer. Per Ms. Heekin's report, there are 67 members who are paid in full and 40 members who have made partial payment for 2008. In order for members to vote in the annual meeting in January 2009, annual dues must be paid in full no later than December 31, 2008.

The GRHA Board approved a new service to the members of our community. You will now be able to advertise your business by displaying your business card in our Newsletter or Board Updates, which are planned to be sent out 6 times per year. This service is free to our paid members, however, there will be a charge of \$100.00 to non-members.
